NOTICE OF OPPORTUNITY TO COMMENT

PROPOSED APPROVAL OF AN AMENDMENT TO THE WATER QUALITY CONTROL PLAN FOR THE SAN DIEGO REGION TO INCORPORATE BIOLOGICAL OBJECTIVES

NOTICE IS HEREBY GIVEN THAT the State Water Resources Control Board (State Water Board) will accept comments on the proposed approval of the California Regional Water Quality Control Board, San Diego Region's (San Diego Water Board) amendment to the Water Quality Control Plan for the San Diego Basin (Basin Plan). The Basin Plan amendment incorporates general narrative guidance for the development of biological objectives and a numeric water quality objective for perennial and seasonal streams using benthic macroinvertebrates and the California Stream Condition Index (CSCI). The Basin Plan amendment was adopted by the San Diego Water Board on December 8, 2020 (Resolution No. R9-2020-0234) and is available for review at: https://www.waterboards.ca.gov/sandiego/water_issues/programs/basin_plan/bio_objec tives/.

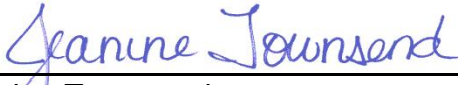
REQUIREMENTS FOR SUBMITTING COMMENTS Pursuant to 23 Cal. Code Regs., § 3779, subd. (f), comments submitted to the State Water Board must satisfy all of the following requirements:

1. Comments must specifically address the final version of the Basin Plan amendment adopted by the San Diego Water Board on December 8, 2020.
2. If the San Diego Water Board previously responded to a similar or identical comment, the commenter must explain why and in what manner the commenter believes each of the responses provided by the San Diego Water Board to each comment was inadequate or incorrect.
3. The commenter also must include either a statement that each of the comments was timely raised before the San Diego Water Board, or an explanation of why the commenter was unable to raise the specific comment before the San Diego Water Board.
